General

External PE coating of steel pipes in accordance with BRL-K767 "External Coating with PE of steel pipes suitable for underground installation" of which NEN 6702 "External coatings with PE of steel pipes and fittings for underground installation" is an integral part.

Additional Specification

This certificate is applicable for the external coating with PE of steel pipes of:

- DN 60 to DN 400.

Application and use

The products are suitable for application in underground transport pipes for gas and water for a continuous operating temperature of maximum 50° C.

Marking

The products are marked with the Kiwa-mark.
